		May income was significantly lower than other months.Gwyneth has pulled a list of people who are behind on their pledge. We need to be more detailed on stats and then identify a plan for high-touch "recovery" and connection with people who are currently not contributing (Lora, Aly, Mallory, Marisa).
		YTD expenses are 10k under budget. Still a deficit, but being tightly- managed. In addition, the market has been very strong, so we are actually not as deep into borrowing from our endowments - it is a temporary reprieve though and the market could change at any time.
		<b>Motion:</b> In order to support our cash flow needs, we will move \$20k from each of the endowments (total of \$60k) into our operating funds. <b>Ginny moved, LeighAnn seconded</b> , <b>Vestry approved</b>
